Trustees are recruited and appointed in line with Clauses 66 – 71 of the charity's constitution.

In summary, at each AGM, the members may elect any member to be a trustee and the board may at any time appoint any member to be a trustee (in each case, unless they are debarred from membership under clause 64).

In addition, the board may at any time appoint any non-member of the organisation to be a charity trustee (subject to clause 61, and providing they are not debarred from membership under clause 64) either on the basis that they have been nominated by a body with which the organisation has close contact in the course of its activities or on the basis that they have specialist experience and/or skills which could be of assistance to the board.

Objectives and activities

Charitable purposes

The organisation's purposes are to benefit the Community of Hoy and Walls geographically defined by post codes: KW16 3NJ, KW16 3NQ, KW16 3NZ, KW16 3PA, KW16 3NY, KW16 3NX, KW16 3NV, KW16 3PQ, KW16 3NW, KW16 3PH, KW16 3PG, KW16 3NT, KW16 3NT, KW16 3NR, KW16 3NS; in the following ways: -

- 4.1 The provision of recreational facilities, or the organisation of recreational activities, with the object of improving the conditions of life for the persons for whom the facilities or activities are primarily intended;
- 4.2 the advancement of citizenship or community development;
- 4.3 the advancement the arts through the organisation of community events;
- 4.4 the promotion, establishment, operation and/or the support of other similar schemes and projects of a charitable nature for the benefit of the residents of the Community;

Summary of the main activities in relation to these objects

No activity has been possible due to the circumstances of COVID_19 during the period, other than to encourage members of the community to contribute to an informal on-line "Hoolie" where individuals in the community who wished to posted their own videos to the Facebook page to be enjoyed by the whole community in an attempt to keep spirits uplifted during pandemic.


